<u>CALL TO ORDER</u>: Meeting called to order at 18:00 hours at station 72, on November 9, 2022. The Pledge of Allegiance was led by Commissioner Chair Bill Dickinson.

PRESENT: Commissioner Chair Bill Dickinson, Commissioner Vice Chair Robert Cernick Commissioner Justin Zipperer, Chief Sinclair, Deputy Chief Hutsell, Finance Admin/District Secretary Micallef had an excused absence, Admin Assistant Sandy Malcolm was filling in. Availability to log in and listen online was available. Two members of KCFD7 volunteers were present and one member of the public.

ADOPTION OF AGENDA: Commissioner Vice Chair Cernick moved to approve the agenda, Commissioner Zipperer seconded the motion and the Board voted 3-0 to approve the agenda.

- Citizen on Lambert has contacted Chief Sinclair about insurance going up due to lack of volunteers at Station 72. Chief is working with WSRB to resolve.
- Chief Sinclair has 160 hours of vacation to burn in December and will be taking vacation.
- Hybrid online version of Commissioner Meetings no longer required. Suggest stopping it. Motion to stop having online meetings was made, motion was seconded by Commissioner Cernick was made, the Board unanimously agreed to stop doing hybrid meetings.

- Chandler Wesson graduated from the WSP Fire Academy, and the graduation was attended by Deputy Chief Hutsell and Micallef.

a. 2023 Budget: Commissioner Vice Chair Cernick motioned to approve the 2023 Budget presented, Commissioner Zipperer seconded the motion. The Board voted 3-0 to approve the 2023 Budget. Commissioner Chair Dickinson thanked the Chief and Staff for their hard work on the Budget.
